SECOND-DEGREE STUDENTS

We recently learned that second-degree students do not have to participate in New Student Orientation. As a result, they do not schedule advising appointments in Slate. We have been using the Slate advising appointments to prioritize our transcript articulation. Second-degree students require additional time to complete based on the amount of credit they have earned. To ensure these students' evaluations are complete before your advising appointment with them, please notify our transfer credit team (transfercredit@charlotte.edu) as soon as the advising appointment is scheduled. We want to ensure you have those results prior to the appointment. This is our best path forward until we find a better, more proactive solution.

FUTURE PROFESSIONAL LICENSURE LOCATION

In October of last year, the Department of Education published [88 FR 74568](#), entitled "Financial Responsibility, Administrative Capability, Certification Procedures, Ability to Benefit (ATB)". In that publication, institutions are now required to educate and ensure that students pursuing programs, that lead to licensure or certification, are able to utilize in the state they plan to work after program completion. This requirement applies to undergraduate and graduate programs and became effective on July 1, 2024. Students select their future licensure location at the time of admission and may choose any U.S. state, province, or territory. Students can update their future licensure location at any time, as they may not know where they plan to work until closer to the end of their program of study.

With the help of OneIT, we have introduced an attestation form for students to submit their intended licensure state. We recommend that students use this form instead of sending an email, as it will be more convenient for them. A link to this form is available on the Office of the Registrar forms page, which can be linked to from any departmental or informational web page. Below is the direct link to this form.
